Child sexual exploitation exists everywhere in the world and Laos is not an exception. While Lao is opening up its borders in order to integrate itself in the region with the ASEAN Economic Community, these opportunities will of course come with challenges. One of those challenges is transnational crime, which includes child sexual exploitation in travel and tourism. As a tourism destination, Lao PDR continues to attract tourists. I believe that amongst these tourists, there will be some travelling child sex offenders, who will seek to exploit children in the countries that lack comprehensive legal frameworks that will make them accountable for crimes against children.

The discussions today are very significant in sharing experiences within and across borders, and in particular, in capturing lessons learned from Lao PDR's neighboring countries. The workshop will also assess the Lao legal framework with the objective of possible legal reform as appropriate.
