The first Civil Society Forum: In-depth Discussions on Corruption



The tenth session of the Conference of the States Parties (COSP) to UNCAC in Atlanta, USA saw a record number of civil society attendees: 948 participants representing 320 NGOs. CSU collaborated with the Bureau of International Narcotics and Law Enforcement Affairs (INL) and the UNCAC Coalition to organize the Civil Society Forum on December 10, 2023. The forum was attended by approximately 400 delegates, both in person and virtually. The forum included two high-level panels and breakout sessions, providing an opportunity to discuss in-depth the resolutions and relevant thematic areas: Public Procurement Transparency; the Link between Corruption and Transnational Organized Crime; Civil

Society's Role in Addressing Enablers; Countering Corruption to Reduce Gender Inequalities; Beneficial Ownership and the Misuse of Corporate Vehicles; and Promoting NGO Engagement in Multilateral Bodies.

During the "ASEAN for Good Governance: addressing cross border corruption and transnational crime" conference held in Penang, Malaysia on 5-6 December, the Civil Society Unit conducted a training session on UNTOC and its Review Mechanism.

Accelerating the implementation of international drug policy commitments in Africa through civil society action



From 8 to 10 November 2023 the African Union Commission, in cooperation with UNODC, UNAIDS, the World Health Organization (WHO), and the U.S. Bureau of International Narcotics and Law Enforcement Affairs (INL) organized a High-Level session on Addressing Drug Use and Substance Use Disorders among Youth, Women and Children in Lusaka, Zambia. The meeting gathered ministers and government officials as well as experts from international organizations and civil society, including NGOs and academia to exchange on best practices and challenges in addressing the rising drug abuse among youth, women and children in the continent.
