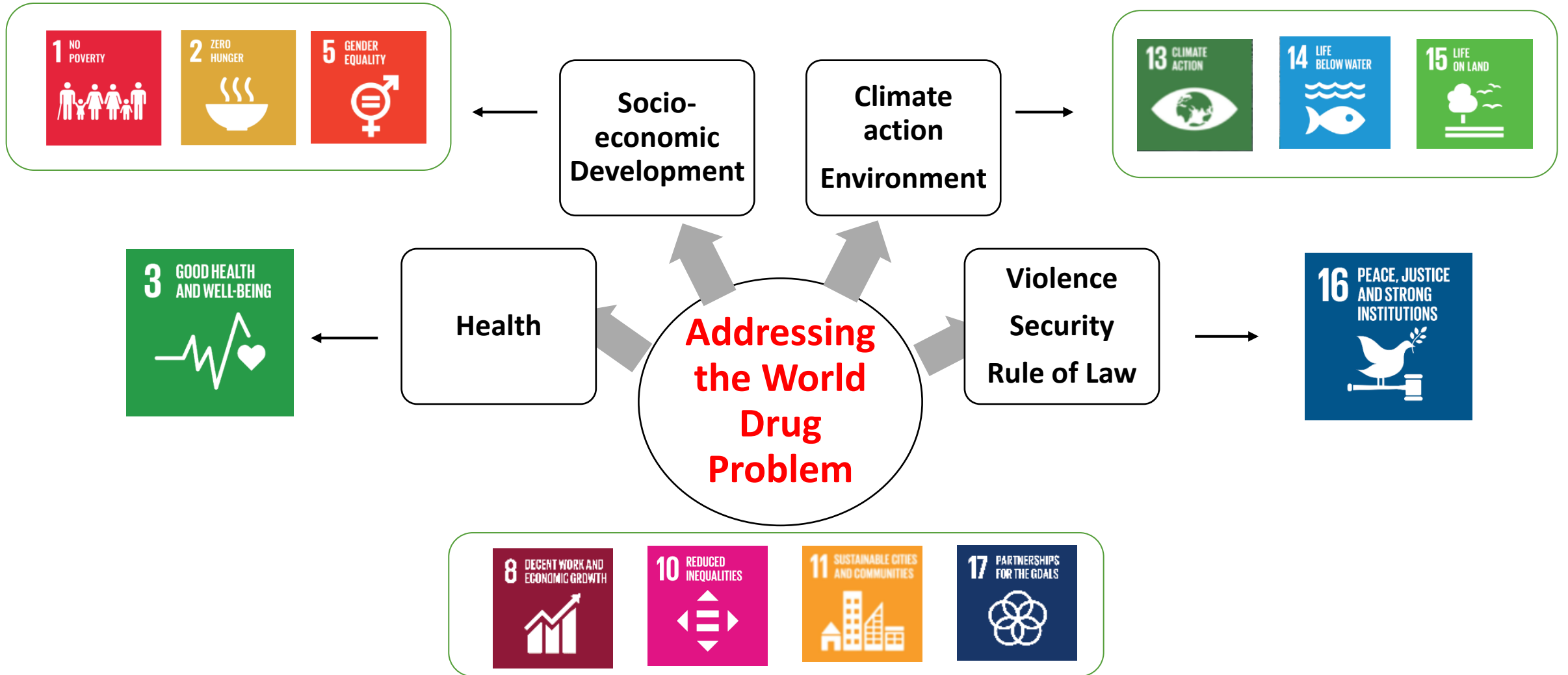

66/1

### Preparations for the midterm review

The Commission outlined the modalities of the 2024 mid-term review which will enable stock-taking of the implementation of all drug policy commitments and the work to be done to accelerate the implementation in 2024-2029 all commitments.



Safe handling and disposal of synthetic drugs, their precursors and other chemicals used in the illicit manufacture of drugs — encouraged adequate practical procedures that are environmentally responsible and ensure the health and safety of persons.

Strengthening information-sharing to increase scientific evidence-based support for international scheduling and the effective implementation of international scheduling decisions



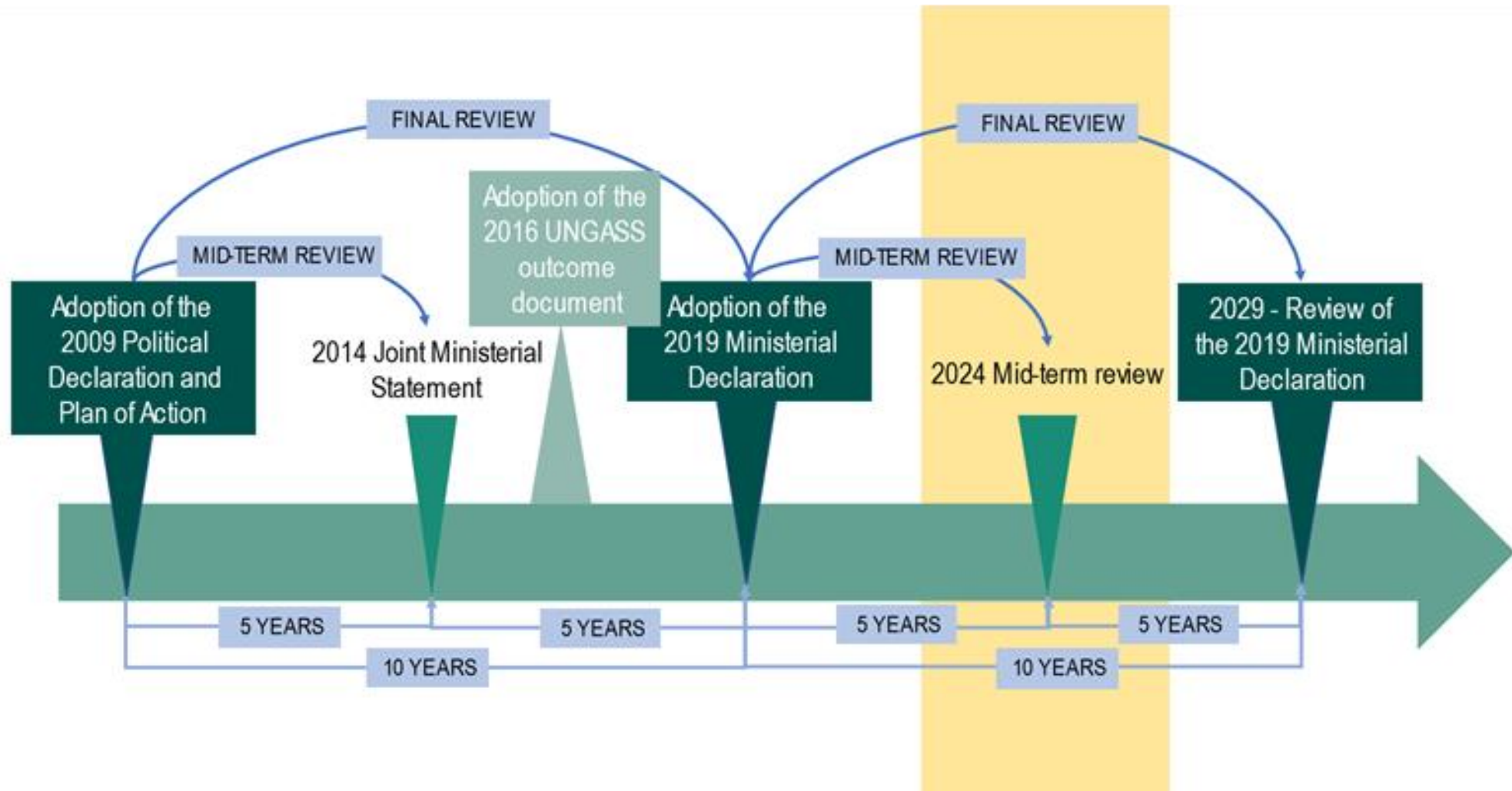
