Case Law Database

A comprehensive database containing jurisprudence, which allows users to see how Member States are tackling criminal cases in their courts.



CNA Directory

A directory of competent national authorities designated to receive, respond to and process requests pertaining to mutual legal assistance, extradition and transfer of sentenced prisoners, smuggling of migrants, trafficking in firearms and trafficking in cultural property.



Legislative Guide

A guide to assist States seeking to ratify and implement the United Nations Convention against Transnational Organized Crime (UNTOC).



Strategies Database

A database containing plans of actions and strategies, adopted at national and regional level.



Database of Legislation

An electronic repository of national laws relevant to the topics covered by the fifteen crime types and searchable by country, UNTOC article, crime type and cross-cutting issues.



Bibliographic Database

An annotated bibliography providing synopses of key articles that are searchable by country, research methods and keywords.




Treaties Database

A database containing the ratification status of international, regional and bilateral agreements and treaties.

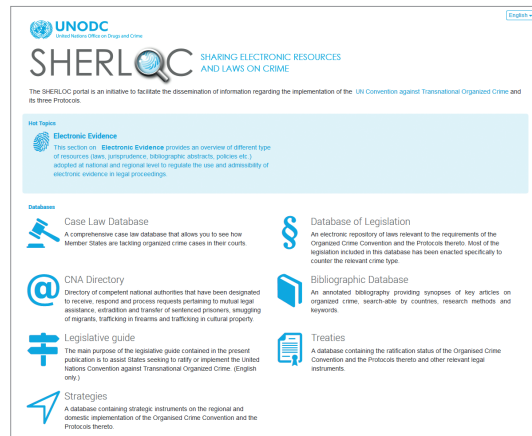

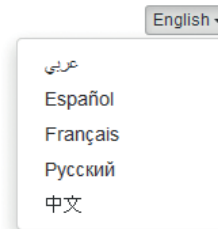
